# 7.C MARKET DRAYTON MESSENGER

Councillor Whittle proposed, Councillor Hughes seconded and it was RESOLVED:

To suspend standing Orders for up to fifteen minutes to allow Hamish Armitage, the producer of The Messenger to speak.

Mr Armitage explained to members that he, trading as Drayton Works, has been publishing The Messenger for the last nine years. During this time, he has thoroughly enjoyed working on the magazine, but he would now like to step back and eventually retire.

The Town Council pay Drayton Works a contribution towards the production of the magazine. Mr Armitage said he would like the Town Council to agree that production and the financial responsibility for the messenger be transferred from Drayton Works to Market Drayton Traders Association.

Mr Armitage explained that representatives from Market Drayton Traders Association have been involved with the production of the last few editions and that going forward he would still be overlooking and guiding them closely until such time he was confident they could produce it on their own.

Members formally thanked Hamish for all his hard work in producing The Messenger over the years.

The meeting went back into Standing Orders.

Councillor Hughes proposed, Councillor Roberts seconded and it was RESOLVED:

To agree to the transfer of the production and payment to produce The Messenger, from Drayton Works to Market Drayton Traders Association.

### 10.C SHROPSHIRE COUNCIL UPDATES

Councillor Aldcroft reported:

- Shropshire Health Authority and The Wrekin authority will be combining forces from tomorrow; they are now called The Integrated Care Bureau.
- It has been proposed that the mobile breast screening treatment unit, which
  regularly comes to the Medical Practice, be permanently based at Telford
  hospital. Concerns have already been raised about the change due to the large
  number of patients accessing the service and it has been highlighted that due to
  the lack of public transport some patients will not be able to travel to Telford. A
  meeting has been organised to discuss the issue; Councillor Aldcroft to report
  back to committee.

Councillor Hughes proposed, Councillor Whittle seconded and it was **RESOLVED**:

To write a letter to Shrewsbury and Telford Trust expressing Town Councils concerns and indignation on stopping the mobile breast screening treatment unit coming to Market Drayton.

- LED replacement lighting to Shropshire Councils property is slowly being rolled out; all work is committed to be complete by 2024.
- The A51 main road through Woore will be closed between 18-24 July for approximately six days to have a sewer pipe put into the new development.

Councillor Nellins reported:

- The Future Connectivity Plan Consultation was held last month, it was well attended and went very well; the results will now be reviewed by WSP and it is hoped funding will be secured to improve the town.
- City Signs have conducted the Local Cycling/Walking Infrastructure Plan recently; he was hopeful something good will come from it for the town.

- EV chargers are being rolled out across the county; Market Drayton has three chargers on Queen Street car park; these will be connected this month. A bid for a further three hundred EV charger's points have been submitted, if successful more towns will have points fitted.
- Shropshire Council are conducting a trial with Pave Cross, a channel across the footpath to the parking space for people who have an electric vehicle with no offroad parking. He urged people in this position to contact him.
- Market Drayton residents should receive their purple lidded recycling bins by the beginning of August.
- The recent funding bid to improve public transport was unsuccessful; other bids are being processed and it is being vocalised on our behalf how unhappy Shropshire Council are with how the funding was awarded.
- Highways issues regarding the potholes and road marking are being addressed,
- There have been some issues raised recently about unsafe buildings within the town; Shropshire Council are not responsible for carrying out the repair work, they can however serve notice on owners to make buildings safe; recently a legal notice was serviced to the owner of a shop in Stafford Street.
- The Shropshire Council Local Bus, which parks outside the Town Hall once a month, has been very well used by residents
- Market Drayton Community Enterprise are organising a Go Greener Event on Wednesday 13 July at The Festival Drayton Centre and urged people to attend.
