8.C PRECEPT 2025-26

Documents showing the budget, income, shortfall in budget, Earmarked Reserves and bank balances was circulated to members as set out in Appendix CO128 and CO129.

Members discussed that the precept was not increased in 2024/25 resulting in the Council taking the $\pounds 5,996$ shortfall from general reserves. As the cost to provide services has increased, members considered increasing the precept for the next financial year.

Councillor Hughes proposed, Councillor Manton seconded, and it was **RESOLVED** with 1 vote against and 1 abstention:

- To increase the precept for 2025-26 by 3%.
- The precept request to Shropshire Council will be £585,214.
- The Band D Council Tax Charge per annum to be £136.02; an increase of £3.96 per year.

11.C TOWN CENTRE WORKING GROUP

i. The Chairman said the Working Group was formed two years ago; various problems have been found including some serious electrical issues.

The Working Group last met in August for their fourth inspection of the town which took two days to complete; eighty-seven issues were raised and a further twenty-five new issues were highlighted. Eighty letters have been sent out highlighting the issues to the property tenants/owners.

During the inspection it was noted that the town looking unkept and messy. A meeting took place with the Street Scene Officer at Shropshire Council to discuss further. The meeting went well; the Officer agreed to look at some issues raised and was keen for the Council to keep logging all issues found on the 'Fix My Street' portal; doing this will provide a clear record and they must be actioned.

12.C SHROPSHIRE COUNCIL UPDATES

Councillor Nellins reported:

- <u>Budget</u> Shropshire Council are currently facing many challenges due to the budget settlement from Central Government; the council will be speaking to MPs to raise their issues. A budget consultation is currently being held; he encouraged members to read it and submit their comments.
- <u>'Fix my Street portal</u> Works on the 'Fix my Street' portal have been delayed due to budgetary issues.
- <u>Highways</u> The weather has had a major impact on the highways department; rain has caused a lot of flooding, a lot of trees have fallen down in the storms and icy roads needed gritting.
- Bus services The maximum bus charges will be £3 from January, the X64 bus service from Shrewsbury to Hanley has increased and work is in progress for a new bus route to Telford; this should be organised by April.
