**5.CG POLICE & CRIME COMMISSIONERS TOWN AND PARISH COUNCIL SURVEY
2025**

To consider and respond to the Police & Crime commissioners Town and Parish
Council Survey 2025 as set out in Appendix CG85.

The Chair read through the survey and the proposed responses; he said that
some of the answers seem negative as in some instances the local policing team
cannot share information with us.

Council Manton queried the point of the survey as no feedback has been provided regarding the previous survey responses.

6.CG TOWN CENTRE MONTHLY REPORT

The Summer term reports for the Senior and Junior youth clubs from Shropshire Youth Association as set out Appendix CG087 were **NOTED**.

8.CG SATURDAY BUS SERVICE

The update of user numbers on the Saturday Town Centre bus service, which is currently subsidised by the Town Council, as set out in Appendix CG088 was **NOTED**.

The Chair reported that usage of the Saturday Town Centre bus service continues to increase.

9.CG TOWN ACTION PLAN WORKING GROUP

- i. The notes and action plan update from the Town Action Plan Working Group held on 20th August 2025 as set out in Appendix CG089 were **NOTED**.
- ii. The quarterly report from Digital Online relating to Make it Market Drayton as set out in Appendix CG090 was **NOTED**.

10.CG CORRESPONDENCE

To consider correspondence from:

- i. Market Drayton Community Enterprise – a request for sponsorship to purchase a digital display board. See appendix CG091.

Permission has already been given for the electronic noticeboard to be installed on the side of the town hall and for the Town Council to pay for the electricity.

Councillors were in support of the concept of installing an electronic noticeboard and in agreement that a contribution could be made towards the project, but that Council should not be paying for the majority of the costs involved.

To write to the Canal and Rivers Trust expressing the Town Councils concerns about the closure of the facility and request that it is re-opened.

11.CG OUTSIDE BODIES

Councillor Manton gave the following reports:

The Grove School Steering Group – there is a new head teacher who is very proactive and keen for the school to get involved with the community.

The Community Covenant Group – the recent focus has been on the launch project, the creation of a Community and Family hub in the town, a decision has been made for the hub to be based at Festival Drayton; subject to their acceptance.

Active Market Drayton – momentum has slowed down due to the loss of a person who was a major driving force. Funding continues to be a big hurdle along with the Business Plan; conversations are ongoing with Shropshire Council and with sporting bodies.

RESOLVED:



- iii. Luna's Legacy and Little Footprint Support Group – a request to support Baby Loss Awareness Week (9-15th October). See Appendix CG093

The Chair suggested that the ribbons be tied to the fence around the British Legion Memorial on the town park.

After a short discussion,

Councillor Manton proposed, Councillor Blandford seconded, and it was **RESOLVED**:

To support the Baby Loss Awareness week by allowing ribbons to be tied on the town park fence around the British Legion Memorial and for a wave of light service on the 15th October.

- v. Market Drayton Canal Volunteer Group – to consider a request to write to the Canal and Rivers Trust regarding the closing of the canal side refuse collection area at Betton Mill. See Appendix CG095.

Councillors were concerned regarding the closure of this facility and the negative impact it could have as the canal attracts a lot of visitors to the town. It was thought that the site has closed due to accessibility issues.
