i. Members received a presentation from Jackie Jeffries, Citizens Advice Shropshire on the service they provide in the town.

The Chairman introduced and welcomed Jackie Jeffries, CEO From Citizens Advice Shropshire.

Jackie said the Citizens Advice Shropshire have two advisers that have been situated at the GP practice within the town for over twenty years. She gave a detailed presentation on the service Citizens Advice provides to residents of the town.

She explained last year they helped residents with housing, travel, utilities debt issues and PIP queries; most clients have multiple meetings to resolve their issues.

Last year a total of over £300,000 was received by people supported by the service.

The annual cost to run the outreach support service for 2025/26 is £11,278. Half the cost is funded by Drayton Action for Health; the request is for £5,639 from the Town Council.

Jackie Jeffries thanked members for the opportunity to come to the meeting to discuss the funding request.

Councillors thanked Jackie and her team for the fantastic work they do in the community.
