4.CG MINUTES

Councillor Manton proposed, Councillor T. Beckett seconded, and it was **RESOLVED** with 1 abstention:

To agree and confirm the minutes of the Community and Governance Committee meeting held on 26 January 2023.

5.CG <u>VISIT SHROPSHIRE</u>

Documents were circulated prior to the meeting.

A discussion was had about becoming a Gold Member of Visit Shropshire at a cost of £2,500. Erasmus Restaurants Ltd, who have the franchise for McDonald's in town have offered a contribution of £1,000 towards the membership fee and other businesses within the town could join at a later date.

Councillor Manton proposed, Councillor Nellins seconded, and it was **RESOLVED** with 1 abstention:

To become a Gold member of Visit Shropshire at a cost of £2,500 for a year; the Town Councils contribution towards the membership will be £1,500.

£1,500 will come from the Community and Governance budget to cover the cost.

To set up a Working Group to organise what information is provided to Visit Shropshire and encourage other local business to be a part of the membership.

6.CG KINGS CORONATION

 i. Councillor Whittle proposed, Councillor J. Beckett seconded and it was RESOLVED:

To hold a Kings Coronation Event in Queen Street on Sunday 7 May 2023, from 1pm until 4pm.

ii. Shropshire Council are removing the dead tree at the top of Stafford Street. A discussion was had regarding planting a new tree or installing a new planter to celebrate the Coronation.

The tree has died due to infected soil, having a large planter with a tree planted in was considered a better option than re-planting a tree.

There is currently a bench around the tree; when the tree is removed the bench will be moved. As the bench is used regularly it was suggested a new bench be installed in the area.

Councillor Aldcroft proposed, Councillor Manton seconded and it was RESOLVED:

To install a planter at the corner of Stafford Street once the current tree is felled to celebrate the Kings Coronation.

To seek professional advice on the most appropriate and suitable tree to be planted in the planter.

To discuss re-installing a bench in the area at a later date.

7.CG <u>LETTERS TO HEAVEN POST BOX</u>

Documents were circulated prior to the meeting.

A request has been received from Luna's Legacy to have a letters to heaven post box installed at the Cemetery for people to post a letter to loved ones they have lost.

The post box will be provided by the British Ironworks Centre and will remain the responsibility of Luna's Legacy who will regularly empty the letters; there would be no cost to the Town Council.

Councillor Manton proposed, Councillor Nellins seconded and it was RESOLVED:

To install a Letters to Heaven post box at the Cemetery

8.CG THE ROYAL BRITISH LEGION

Councillor Nellins left the Chamber.

The Market Drayton branch of The Royal British Legion are celebrating 100 years of helping support the local armed forces community.

Although Council has not previously given an organisation an award for their contribution to the town a conversation was had on how to best acknowledge all the good work the British Legion has done.

Councillor Whittle proposed, Councillor Aldcroft seconded, and it was RESOLVED:

To give delegated powers to the Chairman and Clerk to purchase a suitably engravable plaque/shield to mark the accomplishments of the Market Drayton Branch of The Royal British Legion over the 100 years.

Initial:

To allow up to £250 from the Community and Governance budget to purchase the suitable plaque/shield.

To make suitable arrangements to present the plaque/shield to The Royal British Legion.

Councillor Nellins entered the Chamber and re-joined the meeting.

9.CG THE MESSENGER

Members considered setting up a Working Group to look at the production and costs of producing The Messenger.

Councillor Manton proposed, Councillor Aldcroft seconded, and it was **RESOLVED** with 2 abstentions:

To set up The Messenger Working Group to look at the production costs of producing The Messenger.

10.CG MARKET DRAYTON SPORTS ASOCIATION ELECTRICAL WORK

11.CG ARMED FORCES DAY

Members discussed holding a small service by the War Memorial on 24 June 2023 to celebrate Armed Forces Day.

Members said there is already a service held at the War Memorial on Remembrance Sunday; Armed Forces day is a non-working day for the military. The Royal British Legion or regiment within the town could possibly be holding a function and a representative from the Town Council could attend.

Councillor Nellins said he will speak to The Royal British Legion and regiment to ask if they have any celebrations planned for the day and report back at the next meeting.

Councillor Sanderson proposed, Councillor Manton seconded and it was **RESOLVED**:

To purchase new Armed Forces Day Flags; money to come out of Community and Governance Budget.

To erect a Flag on the Town Hall flagpole and on poles situated on shops and business down Cheshire Street.

To make enquiries as to what other organisations are planning for the day so Town Council can have a representative there and offer support.

12.CG CLIMATE ACTION

Councillor T. Beckett proposed, Councillor Nellins seconded and it was **RESOLVED**:

To support the request from Market Drayton Climate Action Group to endorse the Cool Shropshire and Telford initiative.

13.CG TOWN CENTRE WORKING GROUP

To agree the terms of reference for the Town Centre Working Group.

15.CG SHROPSHIRE COUNCIL UPDATE

Councillor Nellins reported:

Cost of Living Support

Shropshire Council have issued Cost of Living Support Information for residents who are concerned about the cost of living; he will forward the information sheet to the Clerk to put on Town Councils website and notice boards.

Local Cycling/Walking Infrastructure

The Local Cycling/Walking Infrastructure is supported by Shropshire Council Cabinet and will go out for six-week consultation shortly; further information is on Shropshire Council website. He encouraged all members and residents to get involved with the consultation.

Councillor Aldcroft encouraged comments to be made on the consultation from wheelchair users and to explain their disabled routes within the town and country.

Schools Street Programme

Alexandra Road Junior School will be trialling the programme in September; this will reduce the congestion from the school at drop off and pick up times; further information regarding this is on the Shropshire Council website.

Green Waste

There are no statutory regulations for Shropshire Council to deal with removing green waste. There has been talks to charge for this service, there will be no charge for another year.

Town Service Bus Route

A meeting has been set up at 10am on 14 April at the Town Hall between Lakeside Bus Company, Shropshire Council Transport Group and Market Drayton Climate action Group, all Town Councillor are invited to attend. The outdated bus service routes will be discussed and hopefully revised to include new developments within the

16.CG OUTSIDE BODIES

The Grove School Community Steering Group

Councillor Manton reported that he has attended the third meeting of on 6 March 2023.

The aim of the group is to develop a range of community initiatives which will enhance the image held of the Grove school by the community it serves by addressing social problems evident in Market Drayton.

At the previous meeting attendees agreed to form small groups with each group being assigned initiatives to combat anti-social behaviour, challenging behaviours in children, the burden of poverty in the community, drug use and dealing, the amount of litter on the streets, county lines and dilapidation evident in the town.

Each one of these initiatives was allocated to two team members of the group who presented their plan for their initiative to the group for implementation.

All plans were well received by the group and informally put into motion for each group to commence action upon.

Progress will be measured and reported at each steering group meeting. The next meeting of the group will be held on Monday 18th April.
