Year one: £16,320 with the option of a second daily clean of the toilets at a cost of £6,070.00. Total maximum cost £22,390.

Year two: £16,645 with the option of a second daily clean of the toilets at a cost of £6,191. Total maximum cost £22,836.

Year Three: £16,976 with the option of a second daily clean of the toilets at a cost of £6,314. Total maximum cost £23,290.


11.FG SMALL GRANTS
