9.SF TREE MAINTENANCE

The Chairman said Town Council has previously used both arborists. The trees do have a Tree Preservation Order on them so planning permission will need to be applied for and granted before the works are carried out.

- To agree to submit a planning application for the crowning of the trees.
- To accept Quote 1 at a cost of £1,675 for the crowning of the trees on Prospect Road (opposite the Beacon Community Centre).

10.SF UPDATES/INFORMATION

Members NOTED the following updates/information:

- The trees around the play area on Hampton Drive have been planted. •
- The new play equipment on Grotto Road has been installed. The security fencing is still in place while the new turf settles, and the ground dries out.

A conversation was had about dog fouling on the parks. It was agreed to audit signage on the parks; to ask Shropshire Council how many fines have been issued for dog fouling in Market Drayton, especially on the parks and how many parks have bylaws on them.

- The Tender opportunity for the refurbishment of Towers Lawn Toilets has been published.
- Skatepark Light as the lighting column is over 4 meters high planning permission is required. A planning application has been submitted to Shropshire Council.
- The repairs to the Chapel windows are ongoing.
- The fence at the cemetery has been repaired.
