## 3.SF MAYORS STATEMENT

The Mayor read out the following statement to members:

## 5.SF MINUTES

Councillor Aldcroft proposed, Councillor Chapman seconded, and it was **RESOLVED** with 3 abstentions:

To agree and confirm the minutes of the Services and Facilities Committee meeting held on the 23 March 2023 and 25 May 2023.

## 6.SF TOWERS LAWN TOILETS

Councillor Whittle announced he does not recognise the Council; he believes the Council have acted illegally. Due to this he will not continue to stay at the meeting and left the Chamber.

Documents were circulated prior to the meeting.

A discussion was had on the continued damage to the public toilets. Members discussed installing cameras on the building as this would act as a deterrent and hopefully reduce the damage costs.

Councillor Nellins proposed, Councillor Chapman seconded and it was RESOLVED:

To accept quote B; for the installation of CCTV Cameras at Towers Lawn Toilets at a cost of £1,574.14.

The funds to come out of CCTV Earmarked Reserves.

#### 7.SF CCTV UPGRADE

Members had a discussion on implementing stage 3 of the CCTV upgrade to install new cameras on the Town Park, Buntingsdale Play area and the Skatepark.

Councillor Aldcroft proposed, Councillor Mrs J. Beckett seconded and it was RESOLVED:

For Stage 3 of the CCTV upgrade;

To obtain quotes for the CCTV upgrade of cameras on the Town Park, Buntingsdale Play area and the Skatepark.

### 8.SF CEMETERY - BENCHES

There are currently twenty-four benches in the cemetery; some are in pore condition and some have been put on slabs for foundations of which some have then been used to add additional garden ornaments.

Members are aware this is a very sensitive issue but there is a need to ensure the benches are in good condition and safe to use.

- The Chairman explained that previously resolved that Benches cannot be installed at the Cemetery.
- ii. He recommended the Cemetery Rules and Regulations be amended in accordance with the decision made.
- iii. And that Town Council consider installing a public bench on the new area of the Cemetery.

Following a short discussion:

Councillor Chapman proposed, Councillor Erwin seconded and it was RESOLVED:

- i. To re-affirm of the Council Resolution that Benches cannot be installed at the Cemetery.
- ii. To amend the Cemetery Rules and Regulations in accordance with the decision made above. 'Benches cannot be installed on the Cemetery by members of the public; any benches that appear will be removed by the Sexton".

and

- "The conditions of the benches will be monitored; any deemed to be unsafe will be removed by the Sexton".
- iii. To install a public bench on the new area of the Cemetery. To allocate funds from the Cemetery budget for the purchase and installation of a bench.

A discussion regarding the bench at the back of the War Memorial will be put on a future agenda as an item to discuss further.

#### 9.SF CEMETERY – WAR GRAVES

Documents were circulated prior to the meeting.

Members discussed a request from the Commonwealth War Graves Commission to install signage at the Cemetery to let the public know there are 39 war graves within the cemetery. This is at no cost to the Council.

Councillor Nellins proposed, Councillor Chapman seconded and it was RESOLVED:

To agree to the request from the Commonwealth War Graves Commission to install a standard sign measuring 430mm x 23mm signage at the Cemetery.

# 10.SF COMMEMORATIVE BENCH

Documents were circulated prior to the meeting.

Members discussed installing either a recycled plastic or a teak coronation bench on the corner of Stafford Street and High Street.

Councillor Chapman proposed, Councillor Erwin seconded and it was RESOLVED:

To install a recycled plastic King Charles III Coronation Engraved bench at a cost of £499.23 on the corner of Stafford Street and High Street.

The funds to come out of Kings Coronation in Earmarked Reserves.

#### 11.SF IN BLOOM

Members discussed holding the In Bloom competition again this year.

Councillor Aldcroft proposed, Councillor Chapman seconded and it was RESOLVED:

- i) To hold the In Bloom competition in July 2023.
- ii) The judges of the In Bloom competition to be Councillor Love and to ask a previous winner of the competition who is not entering this year.
- iii) To award each category a local shop youcher:

1<sup>st</sup> prize £30, trophy to keep for a year and a certificate.

2<sup>nd</sup> prize £20 and a certificate.

3<sup>rd</sup> prize £10 and a certificate.

iv) To hold the awards event in September 2023.

The Clerk said she will go ahead and advertise the competition on the website and social media.
