1.PL <u>APOLOGIES</u>

Apologies were received and accepted from Councillor Hughes due to a prior arrangement and Councillor Smith is running late to the meeting.

2.PL DISCLOSABLE PECUNIARY INTERESTS

There were no pecuniary interests declared.

3.PL <u>PUBLIC SESSION</u>

The Chairman said there has been a request from a resident to speak at the meeting.

He welcomed the resident to the meeting.

Standing Orders were suspended to enable the resident to speak.

The resident said he wants to talk about the proposed planning application for twenty-six houses at Milton Drive. He has lived in this area for over forty years; it is very established and he has submitted his objections on Shropshire Council portal but wanted to highlight some points for members to consider.

The proposed site is the same size as the first cul-de-sac on Milton Drive where there are twelve properties, this application is for twenty-six houses which highlights how overcrowded the proposed development is, it lacks enough allocated car parking spaces for each household which would cause congestion and there is no recreational space/park in the area like guidelines request forcing potential children in the new homes to have to cross the busy main road to go to these facilities.

He said the new revised proposals for the application are almost identical; he knows Town Council objected to the first application and hoped they also object to this application.

The Chairman thanked the resident for attending the meeting and sharing his concerns.

The meeting went back into Standing Orders.

To object to this planning application on the following grounds:

- The site is isolated with no recreation area provided; difficult to access other recreational parks due to the busy road.
- Insufficient car parking spaces which will then impact on Milton Drive.
- The three-story houses overlook resident's property; With some redistribution of houses, it would lessen the impact on neighbours.
- The plan is overcrowded.
- The proposed development is situated on a flood plain.
- There are no electric vehicle charging points.
- No solar panels have been incorporated into the buildings.

• No drainage and sewage provisions have been declared.
