Place Plan Working Group Meeting NOTES Tuesday 30th May 2023

Present: Clirs Aldcroft, Hughes, Manton, Nellins Town Clerk & Lucy Roberts, Shropshire Council

1. To appoint a Chair

Councillor Aldcroft was appointed as Chair.

2. Apologies and introductions

All present introduced themselves. Lucy Roberts explained her role in Shropshire Council as Place Plan Officer

3. An introduction to the Place Plan - Lucy Roberts, Place Plan Officer, Shropshire Council.

Lucy explained that Place Plans provide important evidence to support the delivery of the Development Plan for the area. There are 18 Place Plan areas in Shropshire focusing on local strategic infrastructure needs in settlements across the county associated with the planned growth.

Infrastructure can a range of things such as highway improvements (on both local and strategic networks), new or expanded education facilities, open spaces and leisure facilities, health facilities, water, electric and gas utilities etc.

The Place Plans provide a robust evidence base for identifying and prioritising practical infrastructure needs of area and allocating resources appropriately.

Discussions with internal Shropshire Council departments have taken place to identify their known infrastructure requirements. Key departments include Highways, Education, Culture and Leisure and Economic Growth. Only the projects they have identified have been included in the new version of the place plan.

While Place Plans are Shropshire Council documents, and primarily are focused on delivering strategic infrastructure it is important that local infrastructure requirements are reflected in the Place Plans, as these local projects help shape

the area and provide important facilities for local people to use. Town Councils are therefore given the opportunity to nominate additional local infrastructure projects, including when they are expected to be delivered, how much they will cost etc.

Lucy said that the deadline for projects is flexible and projects can be sent through when they are identified in the future using the appropriate forms; SC will then decide if they are suitable, viable projects.

4. To consider the current Place Plan Projects

Members considered the projects listed on the 2020 place plan and compared the listing to those in the new place plan. The following were identified as projects that should be included:

- Wastewater Treatment Works
- Development of Marina
- Rural Transport Issues
- Outdoor Swimming Baths
- Purchase of Cemetery Land
- Improve the Town Centre bus service

Councillor Hughes referred to the wastewater treatment for the town. He said that Severn Trent are not responsible for this as set out in the document.

5. To consider new projects to be recommended for inclusion in the Place Plan

It was agreed to hold another meeting to discuss new projects; the date for the meeting was set as Tuesday 20^{th} June.

It was agreed that all Councillors should be given the opportunity to suggest suitable infrastructure projects for inclusion in the place plan. Clerk to email all Councillors to ask them to email in suggestions.

Lucy agreed to look at the suggestions to agree which were suitable for inclusion; for any that are not suitable alternative funding stream would hopefully be suggested.

6. Any other business

It was suggested that projects that have been funded by CIL should be publicised so members of the public can see what new development is funding in the local area.
