Notice is hereby given that in accordance with Section 18C of the Representation of the People Act 1983 that Shropshire Council (the Council) is to carry out a review of its polling districts and polling places.

The (Acting) Returning Officer (ARO) for the existing and future Parliamentary constituencies will comment on the proposals.
