Shropshire Council (School Streets Initiative – Various Roads, Market Drayton) (No. 1) (Experimental Prohibition of Motorised Vehicles) Order 2024

On 11 June 2024 Shropshire Council made an order to place experimental Prohibition of Motor Vehicles restrictions on the following lengths of roads in Market Drayton:

Alexandra Road - between its junctions with C2001 Shrewsbury Road and U3027 Oakfield Road
Grotto Road – its entirety
Simmons Road – its entirety

The restrictions will operate between 8:15am and 9:15am, and between 2:00pm and 3:30pm, Monday–Friday, during school terms at Market Drayton Junior School.

Holders of a School Streets permit, emergency vehicles being used in an emergency, medical practitioners, statutory undertakes and vehicles engaged in building or maintenance work, taxis and buses, Royal Mail vehicles, funeral and wedding vehicles, and motorised wheelchairs, will be exempt from these restrictions.

This Order comes into effect on 24 June 2024 and will operate for a period of up to eighteen months. The Council will consider in due course whether its provisions should continue in force indefinitely.


